# **History of the ECO System**

Better Emissions (as ECO Systems, LLC originally) started selling the devices after Ben Talamantez and Clark Daywalt (RIP 1949 - 2024) began the process of bringing the device to market in 2003. Clark handled manufacturing, and Ben handled marketing, sales, and distribution.

After Clark became ill and was no longer able to manufacture them, Better Emissions Company LLC was formed in 2021 to carry on, with Better Emissions having all rights to the intellectual property, as well as continuing with product development.

The ECO System is manufactured in the United States.

#### **How it Works**

The device is proven to raise the Reid vapor pressure of the fuel, creating a cleaner burn. Fuel consumption is typically improved by 5% to 20%, and with an increase in engine performance with smoother shifting. See https://betteremissions.com/eco-research.php

# **Testing**

Many formal before/after tests have proven the emissions reduction and improved fuel use. The device is proprietary, with a metal tube and copper inserts, protected by patents and trade secrets.

#### Installation

The ECO System is installed between the fuel filter and the engine, with kits and fittings available to fit most engines, or by connecting the tubes with the appropriate clamps. The device does not require any maintenance, and is warranted for 5 years, but typically lasts longer than the vehicle. Please note that the device is not depending on engine heat to function. Installation does not affect the vehicle warranty, and no engine damage has ever been attributed to the device.

It takes several minutes to install, and minimal tools. A qualified mechanic capable of attaching and detaching fuel lines should do the install. See our website for installation examples.

#### Distribution

Better Emissions sells and distributes the ECO System throughout the United States, and international sales are via ECO Mines LLC.

Mr. Talamantez and distributors have successfully installed many thousands of units on cars, trucks, 18 wheelers, mining trucks, generators, school buses, police cars, boats, and more. The vehicles immediately experience reductions in soot, regens, regulated emissions, and engine maintenance, as well as reduced fuel consumption.
